This training teaches a safe, nonharmful behavior management system by providing the best possible care, welfare, safety, and security needed to recognize and manage crisis behaviors.

SD 150 uses Suite 360 as a resource to teach students coping skills, how to respond to bullying or harassment, suicidal thoughts, and social emotional growth. Attached are the district-wide themes for August and September 2023.

The Threat Assessment/Crisis Plan committee met on Tuesday, September 12, 2023, to review and make recommendations. Provided for review is the South Holland School District 150 Threat Assessment Plan for the 2023-2024 school year.

Weekly, administrators receive a BARK Bulletin that shares an alert of the activities of students' searches on district devices including the 3 categories of sexual content, violence, and weapons. *Bark* can help you protect your kids online and in real life with monitoring, screen time controls, and more.

Securly Classroom is a cloud-based classroom management tool for Chromebooks, giving teachers new freedom to guide, monitor, and communicate with students during class. Remove distractions and keep kids focused on learning Securly

SD 150 has implemented Safe2Help, a 24/7 program for students to share school *safety* issues, find resources to get *help* and find encouragement to *help* others. Safe2HelpIL
